## **BLOG POSTS SUGGESTIONS AND GUIDELINES**

#### POST LENGTH AND TITLE

#### **Guidelines:**

- Your blog post should not be a blatant advertorial for your own services or company.
- You can submit a blog post that you have posted on your own blog in the past.
- Blog posts should be 600 words minimum. 800 to 1200 words is optimal.
- The topic must relate to the services you provide and contain practical advice regarding a critical issue facing dentists/practice owners.
- Your POST TITLE should be between 50 and 60 characters.

### **Examples of post titles:**

- The top 3 billing mistakes practices can't afford to make.
- 3 essential questions to ask your dental broker
- Cybersecurity 101 a checklist of things you need to do.
- What to say when a patient asks [add question here]

## **BLOG POST FORMAT**


Send your post as a WORD document (preferred) or as a plain TEXT document.

#### **BLOG POST IMAGES**

### Send images as separate JPG or PNG files.

At a minimum, I recommend you include a "featured image" to use with your post. (circled in green)

The recommended image size 1200 x 630px

Dental FraudBusters is video friendly.


