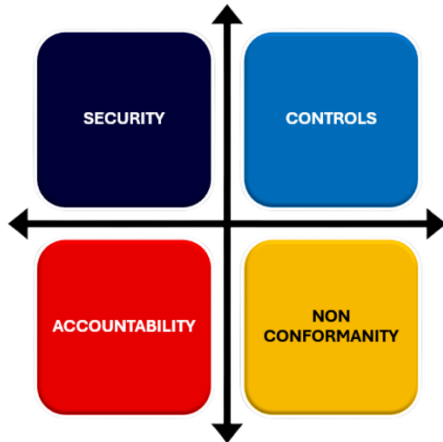
OVERVIEW
